# Benefits Corner

## **Application fees waived for both Undergraduate and Graduate Programs**

If you are interested in applying to graduate school at the University of Connecticut and a veteran your application fee is waived starting with the 2016 fall semester.

This applies to Active Duty, veterans, guardsmen and reservists. For more information go to <http://veterans.uconn.edu/>

## **Eligible for Educational Benefits?**

In order to be eligible for benefits from the Department of Veterans Affairs (i.e. Post 9/11 G.I Bill ) the veteran must meet minimum active duty service requirements.

For most veterans, this means 24 months of continuous active duty. Non-duty periods that are considered excludable are not considered as a break in service for continuity purposes but are to be subtracted from total time served. Minimum active duty service also includes the full period for which a person was called or ordered to active duty. Except as noted below, a person who does not complete a minimum period of active duty is not eligible for any benefit under any law administered by the VA based on that period of active service.

There are circumstances where the above rule does not apply. One circumstance is when a person who is discharged or released under an early out program or a hardship discharge. Another would be to a person who is discharged or released from active duty for a disability adjudged service connected without presumptive provisions of law, or who at the time of discharge had such a service-connected disability, shown by official service records, which in medical judgment would have justified a discharge for disability. A person with a compensable service-connected disability is also excluded.

Other circumstances may apply. When a person does not meet minimum active duty service requirements, and is therefore not eligible for VA benefits, the person's dependents or survivors are also not eligible to receive benefits based on the same period of active duty. **Form D - Available online!** All students (including the regional campuses) can now access and submit the Form D online. Just go to the [Form D link](http://veterans.uconn.edu/) @ <http://veterans.uconn.edu/> and complete it. Remember, the Form D needs to be submitted for **each semester** you want to use VA educational benefits or the State Tuition Waiver.

## Veteran of the Month



SFC Bryce Westlake of Waianae, HI, a beloved father of 3 daughters and husband of 22 years, is the Assistant Professor of Military Science for UConn's Nathan Hale ROTC Battalion. Joining the United States Army at age 23 and then serving for 19 years and 11 months as an active duty 11 Bravo infantry man, SFC Westlake has excelled in education and mentoring cadets in the program. This was shown by the superb performance of 11 cadets that participated in the 2015 Ranger Challenge event held at Ft. Dix, NJ. Being a 2013 Ranger school graduate, SFC Westlake not only provided wisdom but motivation. In this national recognized event, Ranger Challenge tested the cadets' abilities to lead and motivate their team members through a 2.5 day tactically and physically tough competition against 41 other Army ROTC programs. The cadets that participated this year received accolades for their superb tactical proficiency and physical stamina. The success of this event was due to SFC Westlake's level of expertise and mentorship. He spent countless hours outside the classroom honing the skills of these cadets. SFC Westlake has stationed in active duty stations all over the country in bases such as, Fort Bragg, NC, Fort Richardson, AK, Fort Benning, GA and lastly Fort Drum, NY. With time of service came countless awards and schooling, such as, Sniper school (2006), Top Gun Sniper in Sniper school, Air Bourne (1996), Air Assault (1999) and even the Expert Infantry man Badge (1998). SFC Westlake has also been deployed to Afghanistan (2003-2004) as Squad Leader and Iraq (2009-2010) as a Platoon Sergeant. He has also been deployed non-combatively to Panama, Great Britain, Australia, and Thailand.

## Staying up to date with Husky Air Force ROTC



Spring semester 2016 will soon be underway for Detachment 115 at the University of Connecticut. We are welcoming 48 returning cadets from UConn, Eastern Connecticut State University, Central Connecticut State University, Trinity College, University of Rhode Island and University of Hartford.

As we head into Spring 2016, we take a moment to reflect on the academic and event successes of Fall 2015.

Last semester, the Air Force cadets had a cumulative GPA of 3.41 while maintaining outstanding physical fitness. We were pleased to award four full three-year scholarships. These scholarships are based on academic, physical fitness and leadership excellence, with the cadets competing nationally for the awards. The semester's events included Career Day held in October when

sixteen Air Force officers visited UConn and spoke to our cadets. The visiting career officers included Fighter pilots, Cargo Pilots, Bio-environmental and Civil Engineers, Security Forces and Behavior Scientists among others. ## Are VA Education Benefits Taxable?

**No.** Any veterans' benefits paid under any law administered by the Department of Veterans Affairs (VA) should not be reported as income to the Internal Revenue Service (IRS). You will not receive a W-2 from the VA.

### **Per IRS Publication 970:**

*"Payments you receive for education, training, or subsistence under any law administered by the Department of Veterans Affairs (VA) are tax free. Do not include these payments as income on your federal tax return.*

*If you qualify for one or more of the education benefits discussed in chapters 2 through 13\*, you may have to reduce the amount of education expenses qualifying for a specific benefit by part or all of your VA payments. This applies only to the part of your VA payments that is required to be used for education expenses.*

### *Example.*

*You have returned to college and are receiving two education benefits under the latest GI Bill:*

*a \$1,534 monthly basic housing allowance (BAH) that is directly deposited to your checking account, and \$3,840 paid directly to your college for tuition.*

*Neither of these benefits is taxable and you do not report them on your tax return. You also want to claim an American opportunity credit on your return. You paid \$5,000 in qualified education expenses (explained in here in IRS publication 970, chapter 2). To figure the amount of credit, you must first subtract the \$3,840 from your qualified education expenses because this payment under the GI Bill was required to be used for education expenses. You do not subtract any amount of the BAH because it was paid to you and its use was not restricted."*
